- Reducing energy and resource consumption by implementing effective and efficient reduction methods consistent with best practice.
- Minimizing the generation of waste and implementing recycling initiatives.
- Identifying means to reduce our environmental impact in the office and in the wider community through our Environmental Impact Community. During 2022 we introduced the cycle to work scheme and public transport scheme, have organised litter picks in the local community.
